## DISCUSSION ITEMS A. Dara James Playground – Review of Proposed Playground & Related Amenities/Options for Playground Equipment • Public Comments/Input

At the February 2014 Board Meeting, the Board approved the re-location of the existing playground from Leahy Circle (which is on leased property from ComEd) to park district property off of Dara James (approximately 2 blocks west of the Leahy Park location).

The purpose of this meeting is to show park layout concepts and playground equipment options to the public and obtain their input prior to plans being finalized.

Flyers have been distributed in the neighborhood around Leahy Circle and the area around Dara James Street where the new playground area would be constructed. Notices were also posted at Leahy Park and the Dara James location inviting residents to provide feedback and attend the meeting. Information has also been posted on our website as well as Facebook regarding the meeting and requesting resident input.

Copies of the Dara James plan options that will be shown at the meeting are included with your packet, and they are also posted on our website.

Information gathered from this meeting and/or through comments submitted to the park district by June 26 will be reviewed and considered as plans are finalized. The final plans for Dara James would be presented to the Board of Commissioners for approval at their July 23 Regular Board meeting prior to the bid process for the construction of the playground and park area.

At that point we would plan to hold another neighborhood meeting to gather input & comments about playground equipment and other park amenities, and begin development of bid documents for Board review and approval.

Our goal is to complete this project by late fall 2014. Once the new playground is installed at Dara James the equipment at Leahy Circle will be removed.
