
# Voting on Phase I & Phase II of Golf Renovation Concurrently (Discussion Only)

 $\rightarrow$  Staff, architects and Nicholas & Associates continues to toward on Golf Renovation based on the timing as shown in the project timeline.

- → Nicholas & Associates are on target to provide cost estimates for Phase II at the March 19<sup>th</sup> Board Meeting.
- → If the awarding bids for Phase I is delayed beyond the March 19<sup>th</sup> Board Meeting (which would push the start time for Phase I later), there may be issues with successful bidders holding their bid prices longer than was required in the bid specifications. Pushing Phase I later may also have an adverse impact on the timing for completing Phase II.

  - Bids awarded for Phase 1 at the March 19<sup>th</sup> Board Meeting
    - Work on Phase I begins in early April

- It is estimated that approximately \$70,000 \$80,000 of Phase I is eligible for funding through our Special Recreation/ADA fund
